oct 9, 95 v killed

Kim's statement:

rk left abt 7.30 to 7.45 saying he was going to tk's to
borrow the truck to haul the underpinning. Ronnie was
driving the 92 chevy camero. kim left driving the white
dodge daytona

rk called her at noon to see if she wanted him to eat with
her and she asked if he had gotten the underpinning. she
told them ronnie was alone that day and noone else was with
him

ronnie took the box truck back to teds and got the camero
and went to his house. ronnie worked on the underpinning
for a while and then had to go back to lyle's to get a tool
kim says that ronnie called her and told her he was going to
lyles to get the tool abt. 3 p.m.

kim got home at 5.40 p. and ronnie was there and she said
she didn't feel like cooking so they were going to Winn
dixie to get stuffed flounders

they went to jim and judy's and then to winn dixie. they went home and at 8:30 they were eating flounder and watching tv

they went to bed at 9 p.m. and shortly after got a phone call--when they found out abt. the fire they went to teds

ronnie's first interview oct. 30, 96 by naval intell
ronnie says he and kim were in bed btw. 9 and 10 when the woman called and they fd. out abt. the fire
he couldn't get his parents so he and kim drove over there when kim got hysterical he had to take her home

ronnie says that he used to have a rifle, but it was stolen and that ted had a .44 or .45 glock pistol--r tells them that somebody told him that was the gun found beside v's body and must have been the murder weapon

r was asked the last time he saw v alive and he said it was sept 23 or sept 30 when he came over to borrow a game

he tells them the story abt. the drunk

when they ask him for details of his activity on oct 9 he tells them he got up early and got to ted's house at 7:15, got the truck and THEN WENT DIRECTLY TO ATLANTIC MOBILE HOME SUPPLY

this contradicts his later statement that he was at lyles because he waited until it opened and could not remember whether that was 9 or 10
he said he went from atlantic back to ted's business and told him he was going to fill the truck up and charge it to the bus. acct.
then ronnie went back home and it was abt. noon

he unloaded the materials and took the truck back to teds house, getting there abt. 1 to 1.15--he didn't see any other cars in the drive

he drove his car back to his house and started doing the underskirting

a short while later he realized he didn't have a tool he needed, a fine tooth blade for the saw

when he got back to lyles it was abt. 3 and it was busy so he helped with customers for a while and helped steve, one of ted's employees build something

he left lyles abt. 4.30

he started back to work on the underpinning and then james stump came by and ronnie says stayed for abt. 15 mins

he said after james left his wife came home and he spent the rest of the evening with her

he says he seemed to recall that they went out sometime that evening but can't be sure

he said they went to bed early

he told them that they learned during the autopsy she had been shot in the head and that his brother's gun was beside the body and that was the murder weapon
he told them the murderer set fire to the house by pouring gas over the inside and leaving a trail to the front door where he presumed the person set fire the fire

RONNIE TOLD NAVAL INVEST. ON THE FIRST INTERVIEW--OCT 30, 96 THAT THIS DRUNK GUY CAME UP TO THEM AT THE FUNERAL AND TOLD THEM HE WAS A SUSPECT IN THE CASE, THAT HE USED TO DATE PATRICIA--RONNIE POINTED HIM OUT TO PATRICIA'S BROTHER RUBEN AND HE SAID THAT HE KNEW HIM.

mar. 6, 97 int. by pendergrass and naval intell of justin lee dobish
dobish give elaborate intinerary of trying to get a trailer hooked up and get underpinning, but dobesh says he doesn't htink they ever got it
after he with ronnie all day, dobesh says he leaves g'b ard. 6 p.m.
dobesh nails down that this was mon oct. 9 because on tues. he was expecting ronnie at work and somebody told him ronnie sister-in-law was dead and he was not going to be back at base until later
dobesh took a polygraph
SHERRY WILSON CAN TELL US WHEN DOBESH CAME UP TO GB-- 697-7463 SHE CONFIRMS THAT IT WAS THE WEEK BEFORE

jas. ogburn says that ronnie was there at lyles until ogburn went to lunch at 12.30 but did not get back until 3 p.m. bcs his car broke down
rembers ronnie left at 4:30 bcs. he looked at his watch and sd. to himself that he only had 1 hour until he went home
ogburn has served time in pen

interview with winn dixie employee who knows kim and says she remembers seeing kim on oct. 9 (and also remembers seeing the fire trucks later that night on her way home past ted's house but didn't know who it was)
she knows she met ronnie one time but can't be sure it was that night, she told kim ronnie was a good looking man
she remembers seeing kim in the store two or three times

cross notes ask eyewitness to ronnie at 6.20 to describe the occupants of the other car

**DZIADSZEK TOLD investigators that ronnie told him the last time he was at ted's house was 4 p.m. on the day of the murder and he dropped off the box truck and picked up his camaro int. mar 4, 97

they reinterviewed dziadszek and he told them he told ronnie abt. telling invest. that he dropped the truck oof at ted house at 1600 hrs. and ronnie raised his voice and sd. what are you trying to do get me convicted and sd. i told you i dropped it off at the bus. at 4 and calmed down s v. marecek good s v. hayes marital priv prior statement of v

FIRE NOTE: THEY FOUND A FIREPLACE IGNITER OR LIGHTER ON THE LIVING ROOM FLOOR--why was it there, should have been near the back door

they found the large kitchen knife in the hole where the body was found when they were sifting through debris looking for shell casing

RONNIE HELPED A GUY AT LYLE'S WHO SAYS THAT RONNIE WAS STILL THERE AT 4:30 have him testify for us

WE NEED TO ARGUE TO THE JURY THAT HOW MANY TIMES HAVE YOU BEEN CUT OFF BY ANOTHER DRIVER AND BEEN MAD AS HELL CAN YOU REMEMBER WHAT THE OTHER DRIVER LOOKED LIKE

IF THE LIGHT WAS COMING FROM ANYWHERE BUT FACING INTO THE DRIVER'S FACE YOU WOULD NOT HAVE BEEN ABLE TO SEE HIM

ingold's theory is that ted had all these criminals around him patrick pardee and nichols etc. who would be the logical choice for him to use to kill his wife

that patricia did the books and found out they were taking in all this stolen material and she threatened to blow the whistle on ted--this was shy he wasn't so concerned about the insurance money that was just an after thought

ingold's knife theory that patricia picked up the kitchen knife they found in the hole and had it in her hand when she came inside to see what was going on

LAURA ANNE SHEPARD: SHE IS RODNEY LAMONT WODBERRY'S GIRLFRIEND--COPS INTERVIEWED HER AND SHE SAYS THAT ON EARLY A.M. OF APR. 5. 1996 SHE WOKE UP AFTER HEARING WOODBERRY CRYING IN THE NEXT ROOM. SHE ASKED HIM WHY HE WAS CRYING AND HE RESPONDED BY ASKING HER IF SHE WOULD COME VISIT HIM IN PRISON. HE WENT ON TO SAY THAT HE HAD ODNE SOMETHING THAT COULD GET HIM THE DEATH PENALTY. WOODBERRY ALSO TOLD HER THAT HE WAS COMING INTO SOME MONEY SOON AND WOULD STILL GIVE HER MONEY WHILE HE WAS IN PRISON.

then took the truck over to ted's and got his camaro and
went back home
called lyles and asked for ted
waited made lunch
ted called asked for saw blade
went back to lyles ard. 3:30 to get the saw blade
then went home and started on underpinning
then he told you he was at his residence with his wife until
he went to his in laws with his wife

told oct. 30 that went back to lyles for the saw at abt. 3
p.m. and then stayed there and helped build a dog house and
left and got back to his house ard. 4:30 p.m.
and that his father in law came by abt. 30 mins. after that

told those investigators that the last time he saw v was
weekend of sept 23 or sept 30

when he was asked who might have had a reason to kill
patricia he sd. there was no reason he could think why
anyone would want to tkill
