Partnership in Crime

Good example of a conspiracy is the arrangement between Ted, Pardee, Nichols and James Ogburn

Significant that Ronnie was not involved.

The profits from selling stolen building supplies would have been a good way to pay Ronnie back since the insurance did not pay.

Not a trace of evidence that Ronnie had any idea of stealing conspiracy.

FOUR CRIMINALS

MELANIE OF BEING SCARED

Patrick Pardee

Rob Nichols (*SCARED*)

Jeff Clark

Rodney Woodbury (*SCARED*) *COMPARE W/ MICK WHIDDEN*

No credibility, especially in a circumstantial evidence case.

PARDEE: Was an old friend of Ted's - no connection with Ronnie. *WAS IN RONNIE'S WEDDING RING*

MELANIE OXENDINE: Cannot be lying - how would she know to make that up?

NICHOLS: 3 time loser

Felonies in California

More felonies in Greensboro

NO PROOF OF ANY KNOW TO REWARD IN WITNESSES

Pardee said Nichols was already bringing stolen goods before Pardee got involved.

STATUTE -
evidentiary

Nichols didn't even need a lawyer

RONNIE'S CREDIBILITY (BACKGROUND IN JAIL)

Wedding picture thing (PATRIC PARDEE IS IN PIC!)

Crying - Dad - Liberty

RONNIE DOES NOT HAVE TRUCKEN
OF PROOF ON ALIBI

CELLULAR CALLS FROM LYLES
TO CAMP LE JUNGLE

NO CALLS ON AND OTHER DAD

OBVIOUSLY THE PHONE RECORDS
DO NOT SUPPORT CLOSE

FRIENDSHIP OR COURSE OF CONDUCT

3:20 p.m.

Only Ted knows where she was going

She went to drop something off or order something.

Was she going to **PRECISION FABRICS?**
(Meadowview)

Left motor running and pocketbook in car

She thought Ted was **at** Precision Fabrics

FINGERPRINTS:

None identifying any suspect

No tests performed on the murder weapon

EXPERT ARSON ANALYSIS:

No specific time that fire was set

Fire could have burned from two to
four or more hours

No exact time of death

THEME OF INTIMIDATION

(1) Church threatened Ronnie on April 1, 1997 that if he found out anyone assisted him in suppressing evidence, he would charge them. (Obvious reference to Kim).

(2) Ronnie will testify that he understood Church meant Kim.

(3) Panosh put Kim and James Stump on State's witness list. Sent Church and Pendergrass to question the Stumps. And to be sure they had read certain letters (Janet Smith).

(4) Panosh had Polly Sizemore call Kim and warn her she could be prosecuted for obstruction.
