4. Narrative: I CONTACTED DAVID GODFREY THE GENERAL MANAGER OF MRS WINNER'S CHICKEN AND BISCUITS LAST WEEK AND ASKED IF HE HAD RECEIPTS OF FOOD PURCHASES FROM 10OCT95 FROM 1730 HRS. TO 1800 HRS. DAVID INFORMED ME THAT THEY DID NOT KEEP RECEIPTS BUT FOR ABOUT ONE WEEK AND THAT THEY DID NOT HAVE ANY RECEIPTS FOR THAT DAY. I ASKED DAVID IF HE SPOKE WITH ANYONE THAT MIGHT HAVE CALLED OR CAME BY AND WANTED OR INQUIRED ABOUT A RECEIPT FROM 09OCT95. DAVID SAID THAT NO ONE HAD CONTACTED HIM ABOUT ANY SUCH RECEIPT NOR HAD ANYONE WHO WORKS THERE MENTIONED IT TO HIM. DAVID SAID HE WOULD ASK THE OTHER EMPLOYEES ABOUT IT AND IF HE CAME UP WITH ANY ONE THAT DID SPEAK WITH ANYONE ABOUT A RECEIPT FROM THAT DAY THAT HE WOULD CALL ME.

THIS INQUIRERY WAS MADE BECAUSE TED KIMBLE SAID HE CONTACTED MRS WINNERS CHICKEN AND WAS TOLD THAT THEY HAD THE RECEIPTS FROM THAT DAY AND THAT HE HAD STOPPED AT MRS WINNERS ON HIS WAY FROM LYLES TO MEET HIS MOTHER AND GIVE HER THE DOG AND THEN ON TO HIS SECOND JOB ON 09OCT95.

and give her the dog and then on to his second job on 1957.
