Narrative: I SPOKE WITH KIMBERLY PALMER IN MY OFFICE ON 11NOV95 AT 005 HRS. KIM SAID THAT SHE DATED TED KIMBLE FOR FOUR MONTHS THE YEAR BEFORE HE MARRIED PATRICIA. IN HER OPINION THE WHOLE FAMILY ACTED WEIRD AT TIMES. SHE SAID THAT TED WOULD STAY LATE AT HER APARTMENT AND ASK IF SHE COULD SPEND THE NIGHT AND SHE WOULD ALWAYS TELL HIM, "NO". AT ONE POINT SHE SAID THAT TEDS MOTHER EDNA TOLD HER THAT TED MIGHT GO TO SLEEP IN THE WAY HOME AND THAT SHE SHOULD LET HIM SPEND THE NIGHT. KIM SAID THAT SHE HAD LEARNED WHILE DATING TED THAT HE WOULD LEAVE HER APARTMENT AND GO HOME AND GO TO BED WITH HIS MOTHER, NOTHING SEXUAL BUT HE WAS JUST A MOMMYS BOY AND SHE WOULD PET AND PAMPER HIM. ON THE NIGHT OF THE ORDER KIM WAS AT THE CHURCH ON SOUTH ELM STREET AND SHE AND SEVERAL OTHER PERSONS OVERHEARD TED MOTHER AND THE FAMILY DISCUSSING WHERE EACH WERE TO SLEEP AND EDNA TOLD RONNIE THAT THEY COULD SLEEP IN THE SPARE BEDROOM, THAT TED WAS SLEEPING WITH HER. KIM SAID THE PEOPLE IN THE CHURCH SORT OF CUT THEIR EYES AT EACH OTHER AND DIDN'T KNOW WHAT TO THINK ABOUT THE QUOTE.

ON THE SUNDAY NIGHT 08OCT95 KIM, PATRICIA AND TED TALKED ABOUT THE PRYER LIFE MEETING ON 09OCT95 AT 1900 HRS. AND KIM WAS EXCITED THAT SHE AND PATRICIA WERE IN THE MEETING TOGETHER AND SHE TOLD TED THAT HE SHOULD ATTEND. TED TOLD HER THAT HE HAD A SECOND JOB AND WOULD NOT BE ABLE TO ATTEND. THIS BROUGHT UP A QUESTION IN KIMS MIND THAT TED KNEW PATRICIA WOULD BE IN CHURCH FROM 1900 TO 2100 HRS., SO WHY WOULD HE CALL HER AT HOME AT 2011 HRS., BECAUSE HE KNEW EXACTLY WHERE PATRICIA WOULD BE AND KIM WONDERED WHY TED WOULD CALL RUEBEN TO CHECK ON PATRICIA BECAUSE SHE DIDN'T THINK THEY WERE THAT CLOSE.

KIM SAID THAT TED CAME TO THE CHURCH BEFORE HE MARRIED PATRICIA BUT WAS NOT THAT ACTIVE AND THAT HE MARRIED PATRICIA THE CHURCH TOLORATED HIM BECAUSE OF PATRICIA.

ON ONE OCCASION WHILE KIM AND TED WERE DATING EDNA, TEDS MOTHER WAS TALKING TO THEM AND TELLING TED THAT HE NEED TO BUY THE LOT BESIDE THEM AND BUILD A HOUSE WHEN HE AND KIM GOT MARRIED. KIM SAID THAT SHE HAD NO PLANS TO MARRY TED AT ALL AND THAT HE DID ASK HER TO MARRY HIM TWO WEEKS AFTER THEY STARTED DATING AND SHE TOLD HIM "NO". KIM KNEW THAT PATRICIA WAS LIKED TED VERY MUCH AND SHE TOLD PATRICIA THAT TED HAD ASKED HER TO MARRY HER AND THAT SHE HAD TOLD HIM THAT SHE WOULD NOT THAT HE SHOULD START DATING PATRICIA THAT SHE WAS THE ONE THAT REALLLY LOVED HIM.

KIM BROUGHT ME A COPY OF THE END PANNEL OF THE BOX OF THE .38 CAL. PISTOL THAT TED HAD BOUGHT HER. SHE SAID THAT SHE HAD SHOT IT WHEN TED ASKED HER TO CALIBERS ONCE WHEN THEY WERE DATING BUT HAS NOT SHOT IT SINCE AND IT'S STILL IN THE BOX. SHE SAID THAT SHE KNEW TED HAD THE PISTOL AND THAT SHE HAD SHOT IT ALSO.
