Narrative: On 11/19/97 at approximately 0830 hrs., Sgt. Faucette, Cpl. Robinson and Officer Baker went to D-floor to search cell D-1-A. Inmate Ronnie Kimble, WM/25 was housed there. Upon arrival, Sgt. Faucette asked Inmate Kimble to step out of his cell. When Inmate Kimble stepped out of his cell, he had two legal pads in his hand. Sgt. Faucette instructed Inmate Kimble to place the legal pads back into his cell. At this request, Inmate Kimble attempted to remove some papers from inside the legal pads. At this gesture, Officer Baker restrained Inmate Kimble by supporting him around his waist until he was lying down on the bunk. Then Inmate Kimble attempted to stuff the paper into his mouth and tried to chew the paper. Sgt. Faucette was able to grab the paper before Inmate Kimble could chew it and removed it from his mouth. Inmate Kimble was then secured by Cpl. Robinson placing handcuffs on him. Inmate Kimble was then escorted to the visitation area on D-floor. I, Lt. Bennett and Major Nesbit responded to D-floor and observed Inmate Kimble standing waiting for the nurse. Nurse Gwen Reid assisted and observed Inmate Kimble. Inmate Kimble was escorted to the nurse's station where his nose was cleaned.
