Dear Mrs. Rogers:

As I indicated to you in our earlier conversation, I represent Ronnie Kimble. Ronnie is going on trial for his life beginning August 3 in superior court here in Guilford County. You could be a very important witness in his defense. Some of you may be called only in the event that we reach the penalty phase. Others we will call in the guilt-innocence phase of the trial.

I have enclosed a copy of the subpoena you will shortly be served with for your convenience. I have had to subpoena everyone for the beginning of the trial on August 3. It is highly unlikely that you would be needed at that time. It is very important you call me to find out when we will need you. The best time to get me is in the mornings from about 7:30 to 9:30 a.m. It is your responsibility to call me, otherwise you will have to appear in court on August 3 as the subpoena indicates.

I thank you in advance for your cooperation, and ask only for your truthful, honest testimony to help us convince a jury of Ronnie's innocence.
