MUNROE TALKED TO HIM A WHILE ABOUT WHY HE WOULDN'T SPEAK WITH THE SBI AND THAT HE SHOULD COOPERATE AND RONNIE SAID THAT HE HAD TO CALL HIS FATHER FIRST AND IN FACT CALLED HIS FATHER AND TOLD MUNROE THAT HIS FATHER TOLD HIM NOT TO TALK TO ANYONE ABOUT PATRICIAS MURDER.
