DETECTIVE J. CHURCH RELAYED INFORMATION TO ME IN REFERENCE TO INMATE RONNIE KIMBLE. INMATE KIMBLE IS HOUSED IN CELLBLOCK D-1 AND IS IN CUSTODY ON CHARGES OF FIRST DEGREE MURDER AND BREAKING/ENTERING/LARCENCY. DETECTIVE CHURCH RECEIVED INFORMATION THAT INMATE KIMBLE HAS SPECIALIZED MILITARY TRAINING AND MAY KNOW HOW TO MAKE

WEAPONS OUT OF INK PENS, AS WELL AS, HOW TO MAKE OTHER WEAPONS OUT OF SIMPLE EVERYDAY ITEMS THAT WE COULD TAKE FOR GRANTED. HE ALSO CLAIMS TO HAVE SPECIAL TRAINING IN UNARMED COMBAT AND CAN SERIOUSLY INJURE OR KILL A PERSON IN A ONE ON ONE SITUATION. THESE CLAIMS MAY OR MAY NOT BE TRUE BUT WE NEED TO USE EXTREME CAUTION IN DEALING WITH INMATE KIMBLE.

OFFICERS SHOULD NOT HANDLE HIM ALONE AND SHOULD CALL FOR ASSISTANCE IF HE HAS TO BE MOVED OUT OF THE CELLBLOCK AT ANYTIME, WE DON'T WANT ANY OF OUR OFFICERS INJURED SO USE CAUTION WHEN DEALING WITH THIS INMATE. IF YOU HAVE ANY CONCERNS PLEASE CONTACT MYSELF OR YOUR SUPERVISOR.

Ronnie, I guess I've gotten you curious as to why I want to know who your lawyer is. I think I scared Kim to death but she gave me Hatfield's business card anyway. As she was leaving, I tried to reassure her that you were okay and not to expect anything bad to happen to you. (You know that I've got your back as much as is professionally possible!)

The word professional is the key word. I feel like a pre-teen with her first crush and her first case of lust. You absolutely drive me wild and, when I'm on your floor, it's hard for me to stay away from you, let alone keep my hands off of you. Many times I've found myself daydreaming of ways to get you alone, somewhere, for even a brief few minutes. Mentally, I can feel your body responding to my hands as they explore every part of your body.

We've already discussed the absolute need for discretion and I truly feel that you are following my requests.
Once, you →

told me that "A cop is a cop and I don't trust any of you." I think we're past that point and you know that I'm not going to do anything to harm your case, your family, and especially you. Through sporadic conversation, I believe that we have (or are) developed a friendship.

Back to professionalism, last week all employees received a memo about you that really threw me off guard. I immediately got mad but was unable to say anything because of previous accusations. My initial response was to call your lawyer and set up a confidential meeting with him. However, as you already know, I need to stay out of your case and out (definitely!) ~~out~~ of court. All week-end I've been wrestling with my conscience trying to decide what to do. My desire and feelings for you run deep and I don't want you to endure any undue harassment. On the other hand, my badge is very important to me. I worked very hard to get a BS degree for this job. I love my work and hope that this is the beginning of a lifelong career. Part of

Huron County's training procedure is attending a state run school for 9 weeks. This is known as Detention Services Officer Certification. Once completed, the officer is certified by the state and must uphold the rules/regulations/by-laws of the badge. One thing that is stressed heavily and continuously throughout the school is inmate/officer contact. There's always going to be a "Billy Bad Cop", with an attitude, in law enforcement but we are told to treat the inmates with respect and kindness but not to cross the line into friendship. I'm way past that with you. Maybe my fascination and deepening desire is because, somewhere inside, I know that you'll never be here. Who can figure a woman out anyway? Back to the subject... State certification also stresses that any info we received was confidential under all circumstances. Violating this confidentiality could mean loss of the job, revocation of the badge, fines, and black balling from law enforcement. I can't afford any of that crap.

Giving you a copy of this memo would cost me all that I've achieved over the past five years. Yet, I feel that it (the memo) will be important to you. I know that the first thing you'll do is give it to your lawyer. That's fine but, Bonnie, please keep me out of it. If word gets around that you have this, I'll be suspected immediately but, as long as you cover me, there's no proof. I need you to explain to him how important it is that the talk she and I had never happened. I'm also asking (begging) you to destroy this letter and give only the memo to Mr. Hatfield. You are already aware that I'm also under a lot of undue pressure and stress at work and that the supervisors are trying to force me into quitting. This little act would get me fired. I've spoken to a friend of mine, who is also a counselor, and she advises that I'm following my heart, not my head. She also feels that I'm making a huge mistake and that I'll soon be out of work. Bonnie, please don't do that to me. At this point, you

~~You~~ have nothing to lose but I could lose everything. Please give that last sentence a lot of consideration.

I'll be on your poor 11-16-97 (7A-7P). If you need to reply to this immediately, please see Bishop, White, or Cpl Robinson only. Otherwise you have an address to which you can write. Take care and know that I'm thinking of you and praying for you. I'm also entrusting you with my livelihood and pray that that trust is not misplaced. See you soon.
