4. Narrative: I SPOKE WITH TED KIMBLE ON 10NOV95 AT 1025 HRS. BY PHONE AT HIS BUSINESS. TED STATED THAT NO ONE HAD THREATENED HIM AND HE DIDN'T KNOW ANYONE THAT WAS UPSET WITH HIM OR ANYONE THAT WOULD DO ANYTHING LIKE THIS. ^(A) HE SAID THAT HE HAD A GUY THAT HAD WORKED FOR HIM NAMED DINK, THAT HE HAD FIRED BECAUSE HE HAD GOTTEN SMART WITH PATRICIA AND HAD THROWN A BOTTLE AT HIS DAD. I TOLD TED TO GET ME HIS FULL NAME AND I WOULD CHECK HIM OUT. ^(B) HE SAID THAT HIS ATTORNEY STEVE BOWDEN HAD TOLD HIM NOT TO TALK TO ME WITHOUT HIM BEING PRESENT. HE SAID HE WANTED TO CO-OPERATE IN ANYWAY HE COULD BUT WAS AFRAID TO BECAUSE HE HAD NO ENIMINES, DID NOT OWE ANYONE AND WAS IN NOTHING ILLEGAL AND IF HE DID CO-OPERATE THAT IT WOULD LOOK LIKE HE WAS THE ONE THAT COMMITTED THE CRIME OR THAT WE WOULD MAKE IT LOOK LIKE HE WAS THE ONE. ^(C)
I TOLD TED THAT THIS WOULD NOT JUST GO AWAY. HE WOULDN'T WAKE UP ONE MORNING AND EVERYTHING BE AS IT WAS BEFORE, THAT WE WERE GOING TO FIND OUT WHO KILLED PATRICIA NO MATTER WHO IT WAS.
