4. Narrative: I SPOKE WITH STEPHANIE AT HER WORKPLACE 319 WESTWOOD AVE. HIGH POINT TODAY AT 1300 HRS. 21AUG96. SA PENDERGRASS WAS WITH ME AT THE TIME AND STEPHANIE ADVISED THAT SHE REALLY DIDN'T KNOW PATRICIA VERY WELL, THAT SHE WOULD SEE HER AT CHURCH AND THAT HER MOTHER NANCY YOUNG WORKED WITH HER AT CINNAMON RIDGE APARTMENTS.

I ASKED ABOUT THE FRIDAY BEFORE PATRICIAS DEATH WHEN SHE WAS AT CINNAMON RIDGE AND SHE WAS TALKING TO PATRICIA. SHE SAID THAT SHE AND PATRICIA WERE JUST TALKING ABOUT STEPHANIES TROUBLES, SHE WAS PREGNANT AT THE TIME AND THAT TED CALLED HER AND PATRICIA MADE THE COMMENT THAT TED WAS GOING TO WORK AND STEPHANIE SAID I THOUGHT HE HAD A JOB AND OWNED THE LUMBER YARD. PATRICIA TOLD STEPHANIE THAT THEY DID OWN THE LUMBER YARD, BUT THAT THEY WEREN'T SURE IF THE LEASE WOULD BE RENEWED OR IF THEY WERE GOING TO RENEW THE LEASE, SHE COULDN'T REMEMBER WHICH. SHE SAID PATRICIA TOLD HER THAT THE RENT WAS VERY EXPENSIVE AND THAT THEY WOULD PROBABLY HAVE TO SELL THE LUMBER YARD, SO TED WAS SEEING WHAT ELSE HE COULD DO AT OTHER JOBS. PATRICIA ALSO TOLD STEPHANIE THAT SHE AND TED NEEDED \$26,000.00 THEN, FOR THE LUMBER COMPANY.
