4. Narrative: I SPOKE WITH STEPHANIE YOUNG, NANCY YOUNGS DAUGHTER AT HER HOME, 674-1911. STEPHANIE TOLD ME THAT ON THURSDAY 12OCT95 SHE WAS AT TEDS PARENTS HOME WITH HER MOTHER AND THAT SHE HEARD TED SAY THAT HE COULD CLOSE HIS EYES AND SEE PATRICIA FALLING AND HE WAS NOT THERE TO HELP OR CATCH HER. STEPHANIE FURTHER STATED THAT SHE HAD TALKED TO STEPHANIE ON THE FRIDAY 06OCT95 AT CINNAMON RIDGE WHEN SHE HAD WENT THERE TO SEE HER MOTHER NANCY. SHE SAID THAT SHE WAS TELLING PATRICIA ABOUT BREAKING UP WITH HER BOYFRIEND AND THAT SHE WAS PREGNANT AND PATRICIA WAS JUST BEING NICE TO HER AS USUAL. SHE SAID THAT DURING THE CONVERSATION THAT PATRICIA TOLD HER THAT THEY WERE ABOUT TO LOOSE THE LUMBER YARD, THAT THE LEASE WAS ABOUT UP AND THAT THEY HAD TO COME UP WITH \$26,000.00 AND THAT THEY MIGHT HAVE TO AUCTION THINGS OFF OR SELL THE BUSINESS. -
